

**RESOLUTION NO. 24-12-03-01**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
DANA POINT, CALIFORNIA, RECITING THE FACT OF THE  
GENERAL MUNICIPAL ELECTION HELD ON  
NOVEMBER 5, 2024, DECLARING THE RESULT AND SUCH  
OTHER MATTERS AS PROVIDED BY LAW**

WHEREAS, a General Municipal Election was held and conducted in the City of Dana Point, California, on Tuesday, November 5, 2024, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed; and that in all respects the election was held and conducted and the votes were cast, received and canvassed; and, the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolution No. 24-06-18-08 and 24-07-16-06 the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Supporting Document B.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF DANA POINT, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

**SECTION 1.**

**District 4**

Mike Frost ran unopposed.

A certified total of 2,451 of ballots were cast for Mike Frost.

**District 5**

Michael Villar ran unopposed.

A certified total of 2,319 of ballots were cast for Michael Villar

Measure T

Title: An Initiative to Repeal and Replace the City's Existing Short Term Rental Ordinance

Question on Ballot:

"Shall An Initiative to Repeal and Replace the City's Existing Short Term Rental Ordinance be adopted?"

That the certified votes casts were as follows:

NO: 11,839

YES: 6,664

SECTION 3. That the number of votes given at each district and precinct, and the number of votes given in the city to each of the persons above named for the respective offices for which the persons were candidates are as listed in Supporting Document B attached.

SECTION 5. The City Council does declare and determine that Mike Frost (District 4) and Michael Villar (District 5) were elected as Members of the City Council for the full term of four years.

SECTION 6. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing:

- (1) The total number of votes (ballots) cast;
- (2) The names of the persons voted for;
- (3) The measure(s) voted upon; and
- (4) For what office each person was voted for;
- (5) The number of votes given at each precinct to each person; and
- (6) The total number of votes given for and against each measure; and
- (7) The total number of votes given to each person.

SECTION 6. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk or Mayor shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the Office of the City Clerk. Each and all of the persons elected shall then be inducted into the respective office to which they have been elected.

SECTION 7. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
