Mike Holland, Dana Point, spoke regarding a concern he has about Heritage Park. He had observed a landscape crew removing established pine trees in the park. He stated that the slope has not been replanted since the removal of the trees.

City Manager Chotkevys responded that one of the problems we have had in Heritage Park is that the trees have been vandalized. He stated that the City is trying to strike a balance to provide a manicured look to the parks and an individual's property right is not put above the public's property rights. He added that the trees that were removed had been identified by staff and a certified arborist as needing to be taken out.

Richard Gardner, Capistrano Beach, commended staff on their ability to project the finances of the City. He spoke regarding the Doheny Village Plan that he would like to see developed for the area similar to the Town Center Plan.

Mayor Pro Tem Bartlett asked for clarification on the adjustments that are being be made to the CIP.

City Manager Chotkevys replied that the surplus amount being transferred from the General Fund into the CIP fund which will then be available to the Council to appropriate during the year or to consider when creating the two-year budget in the spring.

Council Member Anderson stated that she appreciates the work staff does on this and that the projections are always close to accurate.
