<u>Name of Project:</u> Local Coastal Program Amendment LCPA07-01, General Plan Amendment GPA07-01, Zone Text Amendment ZTA07-02 and Zone Change ZC07-01.

Location: 34202 Del Obispo Street, Dana Point, CA 92629

<u>Description of Project</u>: The applicant, Makar Properties, LLC, is proposing to amend the land use and zoning designations of the subject property from "Dana Point Specific Plan – Coastal Recreation Space" to the General Plan designation of "Residential/Commercial" and Zoning designation of "Residential/Commercial-22". The General Plan Amendment will also entail inclusion of a new land use category "Residential/Commercial" in the Land Use Element.

The project also involves a Zone Text Amendment for the addition of a new zoning district, "Residential/Commercial-22 (R/C-22)", in the Zoning Ordinance. The R/C-22 zoning district would allow for the development of a mixture of residential uses with commercial and office uses in the same building or on the same parcel.

In addition to the General Plan Amendment, Zone Text Amendment, and Zone Change described above, the project also entails a Local Coastal Program Amendment (LCPA). The project site is located within the Coastal Overlay District and also within the Coastal Commission's appeal jurisdiction. An LCPA is required for the new land use and zoning designations for any property located within the Coastal Overlay District. The LCPA is also required for the inclusion of a new land use category in the Land Use Element of the General Plan and for the new zoning district of R/C-22.
