# 12. CITY OF DANA POINT LIBRARY TASK FORCE SUBCOMMITTEE RECOMMENDATIONS FOR THE DANA POINT LIBRARY EXPANSION PROJECT

Mayor Lisa Bartlett had removed this item from the Consent Calendar.

City Manager Chotkevys provided a staff report.

Mayor Bartlett felt that the hiring of a consultant would be a good use of funds and stated that it was time for a new survey. She added that the library resources were important to the community and that the City needs to find out where they fall in the order of priorities with regards to library expansion versus Town Center or some of the other projects the City could plan in the future. She stated that the survey will provide the City with valuable information. She asked if the County relinquished the library building and the property to the City, how would the City operate and handle the costs of maintenance. She also asked how future library expansion would work if the County were to providing any additional funding.

City Manager Chotkevys replied that it will be important to learn what the community wants from the survey.

Council Member Anderson stated that the task force does not want to leave the County of Orange system. She clarified that the concern is if the City does invest in an expansion, who will own the building and will the County have the resources to maintain the facility.

City Manager Chotkevys replied that after the completion of the survey, if there was a desire for expanding services the City would find out if the County did have the funding. He stated then the City could devise a strategic approach to the issue.

Malcolm Wilson, Capistrano Beach, spoke regarding ducklings that were in the storm drain by his home. He stated that he had called the City and staff members had come out and managed to save all but two (2) of the ducklings.

Karen Schnell, Dana Point, spoke regarding the City's new pedestrian bridge that was being built. She reported that the public was invited to the dedication on Friday, May 22, 2009.

Richard Gardner, Capistrano Beach, complimented the City Council and City Staff for the Canary Island Date Palms that were being planted in Capistrano Beach.

#### **PUBLIC HEARINGS**

# 14. APPEAL OF PLANNING COMMISSION DECISION DENIAL OF CONDITIONAL USE PERMIT CUP07-07 AND COASTAL DEVELOPMENT PERMIT CDP07-05 (DEMOLITION OF DOHENY HOUSE)

City Manager Chotkevys introduced the item. Director of Community Development Butterwick provided a staff report and PowerPoint presentation.

City Architect Tilton described the applicant's alternative which would allow for development on the two southern parcels and on the north parcel. He stated that portions of the existing home would need to be demolished in order to accommodate this alternative.

City Attorney Munoz stated that what the Council is asked to do tonight is to make a decision on the appeal of the Planning Commission's denial of the CDP and CUP. He added that they did not have the ability tonight to approve the applicant's new proposal because that application would need to be submitted to the City. He added that he did not believe that the law requires that the EIR be certified by the Planning Commission since the project was not approved. He stated that if the appeal was denied, that the City Council was not legally required to certify the EIR either. He introduced Rob Bower from Rutan & Tucker who had been reviewing this project with the Planning Staff.

Council Member Schoeffel asked if the applicant's second request operates to withdraw the appeal or do you know if that is the applicant's intention.

City Attorney Munoz replied that you could interpret it that way but to be legally, correct absent the applicant submitting a letter formally withdrawing the appeal, the City Council has a legal obligation to consider the appeal as if it had not been withdrawn.

Mayor Bartlett opened the Public Hearing.

John Erskine, Nossaman LLP, stated that this project began in 2007 with an Initial Study which then became a full EIR. He added that at the March 2, 2009 Planning Commission meeting, he felt that there was a consensus of the Planning Commission that they wanted a compromise. He stated that his clients realized that there needed to be a compromise alternative which not only preserved and restored the original 1929 constructed home but also knew that in the current economic climate that they needed to identify financial options that would help them restore the house to the original condition and to the Secretary of Interior standards. He added that they knew that the City Council was the only body that could address the potential need for assuring the financial feasibility of a successful compromise. He stated that the April 23rd letter was a result of the discussions they had with Staff which suggested that compromise. He added that he was available to answer any questions.

Council Member Schoeffel asked that by proposing the new compromise alternative, was it your client's intention to withdraw their appeal of the Planning Commission's decision.

John Erskine replied absolutely not. He stated that his client wants the City Council to act on the appeal and consider the new alternative. He added that it was his experience that the City Council could take action on something that was not in the original application and give direction to Staff to return with an alternative.

Council Member Anderson asked if the Council were to approve the demolition would that take all alternatives and compromises off the table. She felt it would make more sense to withdraw the appeal and return to the Planning Commission with the alternative.

John Erskine replied yes that they would proceed with the demolition if approved. He felt that the Coastal Development Permit could be referred to the City Council but the issue of spending weeks with the Planning Commission and never reaching the City Council did not make sense.

Mayor Pro Tem Weinberg asked if the only decision was to either deny or uphold the Planning Commission decision.

City Attorney Munoz replied that the most recent alternative that has been introduced would require a Site Development Permit and that the application has not been received by the City. He felt that it would be in the applicant's best interest for the City Council to make a decision on the appeal and let the Planning Commission have the opportunity to review the alternative.

City Manager Chotkevys clarified that when Staff met with the applicant, at no time did Staff give them any indication of how the Council may act on this. He stated that Staff responded to their questions relative to the process to ensure that they would have a full and fair hearing.

City Attorney Munoz stated that in response to a comment that Mr. Erskine had made, that he did not want there to be a perception that Staff had polled the Council to find out what their decision was going to be.

John Erskine stated that he concurred with the City Attorney's correction of any comment he may have made regarding any direction or prediction of any outcome. He added that he did stand by his comment that they were encouraged to provide some alternatives following on their appeal.

Mayor Bartlett recessed the meeting at 7:42 p.m. and reconvened the meeting at 8:00 p.m.

Bob Nichols, Dana Point, spoke regarding his article that he had written in 1992 which appeared in the Dana Point News regarding the taking of private property. He stated that when he was on the Planning Commission he had voted against the Historic Preservation Ordinance as he felt that the program would become an involuntary program.

Malcolm Wilson, Capistrano Beach, stated that the applicant knew that the home was protected when they purchased the home. He added that the Council should vote tonight only on the appeal and any alternatives should return to the Planning Commission.

Carlos Olvera, Dana Point, spoke regarding the rules of CEQA and felt that the applicant had not followed them.

Rod Howorth, Dana Point, stated that he supports the denial of the appeal and felt that the applicant should return to the Planning Commission.

Pam Tappan, Capistrano Beach, felt that the City Council had only one choice which was to uphold the Planning Commission's decision. She stated that there were only two options; one to allow the demolition of the Doheny House and the development of five homes, the other to save the Doheny House. She added that demolition of part of the home would remove the historical significance of the home.

Barbara Johannes, Dana Point, felt that the home was historically significant and should not be allowed to be demolished. She stated that there was documentation that proved that Roy C. Kelly was the architect of the home.

City Attorney Munoz stated that if the plans were to be considered by the Council, that copies of the plans will need to be submitted to the Clerk.

Meg Waters, Ladera Ranch, stated that she was working with the applicant on public outreach. She reported that on Saturday, over 300 people showed up for the open house. She added that they had discussed the alternative with the public and the consensus was that the property owner had rights.

Joanna Adrian, Dana Point, spoke regarding personal property rights.

Michael Treadway, Dana Point, spoke regarding property owner's rights. He felt that the home that is on the property today is not the original home. He asked the City Council to review the alternative plan.

Don Ables, Dana Point, spoke regarding private property rights.

Doris Walker, Dana Point, provided a history of the Doheny House. She felt that it was not only the home that was significant, but the people who lived in it as well.

Mary Ann Comes, San Clemente Historical Society, stated that to lose this home or to demolish portions of the home would not be acceptable. She felt that the EIR was not complete and requested that the appeal not be approved.

Keith Johannes, Dana Point, spoke in support of upholding the Planning Commission's denial.

Richard Gardner, Capistrano Beach, felt that the City would need to purchase this property from the owner in order to preserve it.

Raad Ghantous, San Clemente Historical Society, stated that the project EIR had only one objective which was to demolish the home. He felt that if the objectives have changed, then a new EIR would need to be completed to comply with the Law.

Richard Kay, Dana Point, felt that if the demolition was allowed to happen, with the current economy the lots will be left undeveloped until the economy improves.

Anna Brace, Capistrano Beach, felt that the City Council could not make a decision on the alternatives due to the lack of notice.

Richard Boyer, San Clemente, felt that demolition of the home would be inconsistent with the policies of the City and he urged denial of the appeal.

John Erskine, stated that it was not uncommon for historical homes to be relocated. He spoke regarding the comments that former Mayor Harold Kaufman had made at the March 2, 2009 Planning Commission meeting where he stated that the Ordinance was meant to only be voluntary. He asked for the Council to certify the EIR tonight and allow the applicant to bring back the CDP for the alternative.

Carollyn Lobell, Santa Ana, replied in response to some of the comments that had been made that something needs to be done for the home instead of the no project alternative and felt that the EIR was adequate for the partial demolition alternative.

Mayor Bartlett closed the Public Hearing.

Council Member Bishop asked regarding a letter that Carlos Olvera had presented to the City last week, was the letter from Carlos or from the Historical Society.

Carlos Olvera replied that the letter was a consensus of the Board of Directors.

Council Member Bishop asked how a home could qualify for the national registry. City Manager Chotkevys replied that there are certain criterions which have to be met that will raise the home to a certain recognition that would be of national significance.

City Architect Tilton replied that was correct and that when the City placed the home local register, it was noted that the home may be eligible for National registration.

Council Member Anderson felt that it did not make sense to vote to demolish the home if that would take away all of the alternatives.

Council Member Schoeffel stated that the scope of action is very narrow at this time and that he would have to support the Planning Commission's decision of denial.

Council Member Anderson asked if there is not an acceptable compromise reached would demolition still be entertained.

City Attorney Munoz replied that nothing would preclude an application for demolition to be re-submitted.

Mayor Pro Tem Weinberg stated that he would have to uphold the Planning Commission's decision.

Mayor Bartlett stated that she appreciates the community input on this item. She added that the scope is very narrow this evening and that she would agree to uphold the Planning Commission's decision. She encouraged more public outreach.

Council Member Bishop stated that he appreciated the fact that the community spent the evening with the Council. He hoped that there could be a compromise reached.
