Edward Kopp, Capistrano Beach, stated that he submitted a packet for distribution to the Council. He asked that the Council read the letter that was submitted.

Bob Fowler, VFW Post 9934, reported that with support from the City, the Post is able to provide assistance to Marines and their families. He thanked the Council and Staff for the on-going support of the VFW. He reported that the Post will be named All-State in June and will be one of the top posts in the nation. He also thanked the City for the successful car wash that was held April 17th. He stated that on Memorial Day they will be acknowledging the Korean War veterans.

Nancy Jenkins, Dana Point, reported that on June 9th there will be a dinner at Cannon's to celebrate the 5th Marines Birthday. She stated that Mayor Weinberg will be the guest of honor and that the youngest and oldest Marine present will also be honored. She also invited the community to RJ's on May 25th for a fundraiser for Craig Brandmeier who has leukemia.

Joanna Adrian, Dana Point, reported on the Dana Point Coastal Arts Concert series.

UNFINISHED BUSINESS

19. AGREEMENT FOR CONSTRUCTION AND MAINTENANCE WITH THE SOUTHERN CALIFORNIA REGIONAL RAIL AUTHORITY (SCRRA) IN CONJUNCTION WITH THE RAIL HIGHWAY CROSSING ENHANCEMENT PROGRAM FOR BEACH ROAD (MINOR REVISION RATIFICATION)

Council Member Bartlett announced that she had a potential conflict of interest and recused herself and left the Council Chambers at 6:35 p.m.

City Manager Chotkevys provided a staff report.

Mayor Weinberg asked what the difference was between this item and what was approved a year ago.

City Manager Chotkevys replied that a year ago there were some indemnification issues relating to the Construction and Maintenance Agreement for the public safety improvements. He stated that the City has been able to work through all of the issues. He also stated that the City was not certain if there was coverage a year ago from the JPIA and in

fact there was no liability coverage. He added that JPIA staff has found a carrier for the liability insurance and they are willing to go from year to year.

Mayor Weinberg asked what the estimated start of construction would be.

Director Fowler replied that the improvements will hopefully be done by the fall of 2011. He added that they would probably start in the summer to finish by next fall.

Mayor Pro Tem Schoeffel commended the City Manager and Staff for all of their hard work on the project over the past year. He asked if the risk pool extended through Southern California, the State of California, or the United States.

Assistant City Manager Killebrew replied that it is his understanding that the carrier is currently working with JPIA on the policy. He stated that he has not received word that they have been marketing the policy elsewhere. He reported that staff wanted to communicate with Council that the insurance will only be available a year at a time because it is not known if the insurance carrier will find it to be a profitable line of business if there are not enough participants.

Mayor Pro Tem Schoeffel stated that if the insurance carrier broadened the risk pool wide enough, they would hopefully find it to be a profitable line of business.

City Manager Chotkevys thanked Sergeant Koehmstedt, who was the acting Lieutenant while Lieutenant Levy was out of town and Sergeant Greenwood for their Public Safety response at the Doheny Blues Festival. He also thanked Public Works, with a special thanks to Matt Sinacori and Mike Killebrew because they had to shut down day use parking at the State Beach on Sunday due to high surf. He asked Sergeant Koehmstedt if there were any noise complaints this year.

Sergeant Koehmstedt replied that there were no complaints and he also thanked Deputy Gardner who assisted in the planning.

City Manager Chotkevys stated that these types of events benefit the resorts. He reported that the Marriott and the Double Tree were both sold out for the weekend.

City Attorney Munoz reported that there was a recent case that required a Coastal Development Permit for a firework show in the coastal zone. He stated that the Coastal Commission was not in favor of issuing the permit, which resulted in litigation. He added that there are some environmental groups that have been pressing the issue in San Diego with a goal to end free public firework shows on the coast. He stated that he has been exploring the issue as well as potential legislative solutions that anyone may use against the City to prevent the firework programs.

Council Member Anderson stated that she had turned in her meetings attended to the City Clerk. She also stated that the Orange Public Library Advisory Board at their last

meeting passed the budget for the fiscal year 2010/2011. She added that revenue is based on property taxes so the funding for the programs is not doing well. She stated they were able to provide a balanced budget without dipping into reserves and no library hours will be cut. She added that the facility and maintenance projects will be prioritized first by health and safety issues and second by building preservations. She stated that the biggest impact to the public will be that the extra help has been eliminated. She added that the library will now start charging for the five free print outs which will generate a large cost savings. She announced that the Summer Recreation Guide is now available. She also stated that resident Jacinda Smith is setting up a Memorial Service for Lily the Whale on Sunday, June 6 at 9:00 a.m. at Baby Beach.

Mayor Pro Tem Schoeffel stated that he had one of the best weeks in Dana Point the past week. He reported that on Thursday, May 20 he attended the Dana Point Coastal Arts Concert series. He stated that he also attended the Doheny Blues Festival on May 22 and 23. He added that the summer concert series are always well attended and he encourages everyone to attend.

Mayor Weinberg stated that he had turned in his meetings attended to the City Clerk. He reported that Monday, May 31 is the Memorial Day Service at Pines Park and also June 9 there will be a reception at Cannon's for the 5th Marines Birthday Celebration. He added that the Doheny Blues Festival took place the past weekend and it was sold out.
