#### D. PUBLIC HEARINGS

Antenna Use Permit AUP06-04 (Major) for the co-location of new commercial wireless antennas on an existing stealth, freestanding, monopine wireless communications facility and accompanying equipment structure with a Variance V06-07 to increase the height of the 50 foot monopine by eight (8) feet ten (10) inches. (Continued from the regular Planning Commission meeting of April 18, 2011.)

Request: A request to allow the co-location of new commercial wireless antennas on an existing stealth, freestanding, monopine wireless communications facility and accompanying equipment structure with a Variance to increase the height of the 50 foot monopine by eight (8) feet ten (10) inches.

<u>Environmental</u>: This project is categorically exempt (Class 1 - Section 15301 – Existing Facilities) from the provisions of the California Environmental Quality Act (CEQA) because the project involves the minor alteration of an existing public facility involving negligible expansion of an existing investor-owned utility used to provide a public utility service.

<u>Recommendation:</u> That the Planning Commission adopt Resolution 11-05-02-xx approving Antenna Use Permit AUP06-04 (Major) and Variance V06-07.

**John Tilton** (City Architect/Planning Manager) stated that the item was continued to allow the applicant time to place construction stakes at the top of the existing facility to identify the elevation of the antenna.

**Kurth Nelson** (Senior Planner) reviewed the staff report.

### Chairwoman O'Connor opened the Public Hearing.

Jane Collier Norine (Applicant Representative – Irvine) stated that they will comply with the conditions set forth by Staff and made herself available to answer any questions. In response to Chairwoman O'Connor's concern with "Monopines" (aesthetics), Ms. Norine indicated that the original wireless

communication facility already had two existing carriers, and MetroPCS proposed to co-locate services on the existing pine tree tower to serve as a main base and to achieve adequate signal coverage for various device demands.

#### Chairwoman O'Connor closed the Public Hearing.

Commissioner Newkirk stated that the elements of the "monopine" in its surrounding area (trees, vegetation, freeway sound wall) is spatially distributed for cell signal strength. He stated that he would be in favor of supporting the request because its design and height blends in aesthetically with its environment.

Commissioner Claus stated she was not particularly in favor of height variances but, had noted that the location does blend in. She expressed that she "truly" is not a fan of "monopines" because they do not look aesthetically pleasing. She added that aside from tonight's vote, she suggested discontinuing "monopine" facility permits for cellular services in the City.

**Vice-Chairman Denton** stated that he is in agreement with his fellow Commissioners, and was pleased that they were not adding another "monopine". He indicated that because of the surrounding area, the project would blend in. He stated that he is in support of the application because the facility is easily hidden in the eucalyptus trees.

Commissioner Preziosi stated that he visited the site and noted that the appearance of the additional height, as staked out, appears well screened. He expressed concern that if the eucalyptus trees were to come down it would expose the "excessively" tall "monopine." He asked if a sunset provision is tied to the permit. He stated that he was in agreement with his fellow Commissioners and preferred extending the height of the monopine rather than adding a second tree.

Responding to Commissioner Preziosi, Mr. Tilton confirmed that the Commission could specify a two year study requirement to analyze whether there are other available technologies to redesign antenna use facilities as referenced in Condition #13. In this case, the monopine blends in with the living trees which help disguise the aesthetics. It is possible that if the eucalyptus trees were removed, the City has the ability to revisit the project.

**Jennifer Farrell** (Assistant City Attorney) confirmed that Condition #13 includes the language and that the resolution would not need to be modified.

Chairwoman O'Connor stated that she visited the site and indicated that the tree height blended in with the eucalyptus. She stated that she was glad about seeing one monopine, versus two. She stated that she was in favor with the fact that there was a lack of opposition, and the height variance carried valid concerns for technological hardship.

**John Tilton** (City Architect/Planning Manager) gave an update on the Harbor Plan, and stated that the City will be bringing forward the final action document to the City Council for review and approval.

Jennifer Farrell (Assistant City Attorney) gave a status update on the City's litigation filed against California Coastal Commission for acting out of their jurisdiction regarding issues of access at the Headlands; the Court issued in favor of the City last Thursday. She stated that along those lines, the Surfrider Foundation filed a lawsuit against the City claiming that the City did not have enough factual support for a nuisance ordinance regardless of the Coastal Commission's jurisdiction. After intensive briefing, the City is awaiting the Court to issue a decision.
